## Vote NO!

One of the proposed amendments to the AAUW Bylaws removes from the Bylaws the authority and right of the members to approve the biennial Public Policy Program. These are the priorities the members have approved as the basis for all our public policy work, a vital part of AAUW. This amendment means that only the national board would create and approve the PPP. It also means that the Lobby Corps, the member volunteers who go up to the Hill every Thursday Congress is in session, would no longer be able to go to a Congressional office and state that the public policy position they are lobbying on carries the approval of the 150,000 members of AAUW. Since a number of McLean Area Branch members are in Lobby Corps, this is of great concern to them. It also affects our lobbying in Richmond.

All of us will be voting on the proposed Bylaws amendments next spring. (You will also be voting on candidates for the AAUW Board and the 2017-19 Public Policy Program.) At the Nov. 15 branch meeting, the members voted to oppose this amendment. Our statement of opposition will be posted on the AAUW website, and you may state your opposition, too, before Dec. 5. Go to www.aauw.org and click on "time is running out to comment on the bylaws." Then click on "Comment on the Bylaws." Then scroll down to Article XIII. Meetings of the Membership, Section 4. Voting. You can click to see all the comments left to date and put in your own comment. Above all, vote "no" on this amendment when we all get our ballots in early 2017.

# **STEM Awards Ceremony**

The McLean Area Branch recognized six local high school girls with STEM awards at the branch kick-off event held on September 25 at the McLean Community Center. The STEM (Science, Technology, Engineering, and Math) Excellence Award was presented to Mandy Smith, a sophomore at Langley High School, for a project she prepared jointly with Oksana Vickers on "The Effect of Desalination Method on Overall Efficiency." The project was presented at the Fairfax County Regional Science and Engineering Fair held last spring. Oksana received her award at last May's annual dinner meeting.

Five students from McLean, Langley, and Marshall High Schools were recognized with Science and Math Achievement Awards. The students receiving the 2016 awards were: Lauren Hassi, Math Achievement, McLean High School; Caroline Lewis, Science Achievement, McLean High School; Inga Schlier, Math Achievement, Marshall High School; Emma Barberis, Science Achievement, Marshall High School; and Emily Wallach, Math Achievement, Langley High School. The Science Achievement Award, Langley High School, was presented earlier this year to Emily Stranne. All of the students discussed their strong interest in pursuing STEM fields in their high school curriculum, as well as plans for their college studies.

The high school awards process was managed by a committee comprising Margaret Hines (Marshall HS contact), Margie Broderick (McLean HS contact), Barbara Sipe (Langley HS contact), Peggy Stotz, and Judy Page (STEM chair). 

## Authors in our Midst!

Ramona Rayle's book, Odyssey Shared, A Memoir of Sailing and Friendship, was published in

November. The story began in 1972 when she and her husband Bob lived in Greece for three years and became close friends with a couple whose three children were perfectly matched in age with the Rayles' three boys. As the two



families planned their return to the U.S., they discussed returning to Greece after they retired—aboard their own boat.

Their dream was realized 20 years later—after four years of labor on their jointly owned 50-foot boat and testing the waters with short sailing trips—when they departed from Point Lookout on the Chesapeake Bay in July 1991. Their route took them north to Halifax, Canada, across the Atlantic to Gibraltar, to several Mediterranean ports, Tunisia, summer in the Greek Islands, the Aegean Sea, west to the Canary Islands, then a harrowing return

and rescue at sea; they finally arrived home in April 1993.

Odyssey Shared is based on the journals Ramona kept during her two-year adventure as crew on the two-masted Gulf Star 50 that became their home at sea. The journals were mostly written as she kept night watch and sometimes during extended stays in port. Those notebooks stayed closed for many years. More than a decade ago, she decided to take a writing class to determine if her observations of the conflicts among the crew and the characters and cultures encountered during two years of travel would make a worthy story. Her intention was to share the memory of their remarkable journey only with family and close friends. However, after people read various chapters, they encouraged her to publish more widely, recognizing the intimate tale of adventure at sea, friendship put to the test, ancient civilizations and colorful characters was one that others would want to read.

**Dorothy Hassan**'s latest novel *The Blitz* 

Business was published by Koehler Books in August of this year. She writes under her maiden name D. A. Spruzen. "I had a fantastic book launch party at "One More Page Books" in Arlington, VA in September. Over 50 people came, listened to my reading, and



asked lots of good questions. The store sold out of their stock of *The Blitz Business*! A big thank you to all who came."

The Blitz Business opens in London's East End on December 29, 1940, when the Blitz is at its worst. Jamie is almost 15, has mild retardation and lives with his grandmother and cousin Roy as a virtual shut-in. He wanders away from home and soon finds himself in the midst of circumstances beyond his comprehension. He survives many harrowing predicaments, including one that tests his courage when someone he loves is in mortal danger. He feels hope and despair in

turn as he struggles to make his way after a confusing evacuation to the Hampshire countryside.

In spite of a life of deprivation, Jamie learns and grows over the next year, endearing himself to just about everyone he meets, some of whom will fight for his right to lead a normal life. But the authorities have their own ideas about his proper place, his past is still not entirely behind him, a German spy's mission intrudes, and things get out of hand.

Dorothy served on the board of Langley Residential Support Services for ten years and has first hand experience with the prejudice and suspicious attitudes suffered by those with intellectual disabilities. She learned that acceptance and understanding, not to mention exposure to the good things our world has to offer, are crucial to their enjoyment of a rich and fulfilling life.

At the Nov. 4, 2016, AAUW Board Meeting, the following topics were discussed |

#### 1. Amendments to Branch Policies

- 4. Discussion about membership recruitment, including targeted age groups, programs and approaches for recruitment, AAUW programs such as Start Smart and Work Smart.
- 5. Presentation of recommendations from the Allocations Committee, concerning uses of 2016 Book Sale proceeds in 2016-2017 approved by the Board, for vote by membership.
