

The Political Road Ahead

The song or refrain goes, "stand together for what you believe." AAUW recently published the 12-step program, or principles, for these uncharted political waters, here now and ahead.

Through the current confirmation process, not yet complete as of this writing, personnel decisions are policy decisions. **We should view nominations in light of AAUW's public policy**

principles and act!

AAUW's work has always been political but has never been partisan. Political work can be characterized as taking policy positions and working toward a common goal, represented by the member-adopted Public Policy Program. Partisan activities maintain a firm adherence to a party, faction, or person.

A personal belief is that democracy survives only through knowledgeable voters. Thus the basis of sound public policy and change depends on the communication of facts, some based on scientific research.

AAUW stands against bullying, bias and bigotry. Be aware of such groups, as the **Anti-Defamation League** and the **Southern Poverty Law Center** to whom you may report hate speech or incidents. They are also sources for gaining an understanding of current events. We should also continue to support women leaders, especially those who represent our values.

A reminder: this was the first presidential election without the full protections of the Voting Rights Act of 1965. Since the 2013 decision of the Supreme Court, many states have been free to pass damaging voting restrictions in response to claims of voter fraud. Virginia is one of those states.

In the current moments of breaking news, AAUW provides information and opportunities for individual action on its website including Two-Minute Activist. For up-to-the-minute information on voting in Congress, examine the Washington Post local section on Thursdays. The listing features the actual votes of our local members of Congress. It's very informative.

Finally, we in Virginia have the opportunity and the obligation to arm ourselves with knowledge and organize for action this year. We will be voting for a governor, all of the Virginia delegates, some of the state senators, and Fairfax County chair and supervisor, as well as the Board of Education. All politics is local, as we have heard through the years.

Just Do It

Fifty Lobby Corps members gathered on Thursday, February 2 to deliver the AAUW message to House members. The following Thursday, the Lobby Corps members were directed in two ways. One was to greet newly elected members of the House and orient them to AAUW. Of course the 'greeting' means that the legislative aides or the legislative directors are the focus of our greeting and discussion. For the other members of Congress, Lobby Corps members urged them to cosponsor the Family and Medical Insurance Leave (FAMILY) Act. This is a **bipartisan attempt** to move toward providing some portion of a person's salary when he/she is obliged to stay home to care for a newborn or ill family member.

Finally, we make politics local by actually visiting the home office of our members of Congress. The purpose is to inform them about AAUW's stance on issues and to request them to respond to our specific questions. Let me know if you're interested.

January and February 2017 Board Meeting Notes

The following topics were discussed |

1. Amendment to Branch Bylaws (to be presented to membership for a vote)

Passed a motion to present to the membership at the March annual meeting a revision in the way the Branch approves the annual budget. This would include distribution of the proposed budget in May to all members, with time for response and questions, and approval of final budget at the joint Board meeting in June, before the start of the fiscal year, July 1. (This change requires an amendment to the Branch Bylaws.)

2. Membership Growth

Extensive discussions at both January and February meetings to look at ways to expand membership and reach a wider age range of individuals, possibly by offering more varied program and meeting times. Membership V.P.'s drew up a 6-month task plan with assignment of tasks to specific officers, V.P.'s, and creation of a new membership committee.

3. Conferences and Convention Committee Guidelines

Report received from the newly created Conferences and Conventions Committee, setting up guidelines and proposed disposition of funds for officers and members attending national convention (June), state conference (April), and leadership training program (summer).

4. Discussion about archiving Branch records and historical materials.

Virginia AAUW Stops an Assault On Your Right To Vote!

Proposed Bylaws Amendment

At the March business meeting, the Branch members will be asked to vote on an amendment to the Bylaws. The Board of Directors, at its February meeting, voted to approve and send it to the Branch members for approval.

Background

At its October 7, 2016, meeting, the McLean Area Branch Board of Directors considered concerns from members that the current process of **budget adoption** in **late September** means that the fiscal year is already almost three months old and monies have already been spent before the operating budget is approved. After one of the co-presidents surveyed other branches' timing and processes for budget adoption, the Board approved a motion at its November 4, 2016, Board meeting, directing the Bylaws Committee to prepare an amendment to the Bylaws stating that the Board will approve the annual budget at the Joint Board meeting in June.

Amendment

Therefore, the Board of Directors is proposing the following amendment in the 10/15/2016 Bylaws:

Strike the words in Article VI, Section 4, Operating Budget a. APPROVAL

"The annual operating budget shall be adopted by the Board of Directors and presented to Affiliate members for their approval no later than September 30."

Insert the words in Article VI, Section 4, Operating Budget a. APPROVAL

"The proposed operating budget shall be distributed to Affiliate members for review and comment following the May Board meeting according to procedures in the policies. Following the comment period, the annual operating budget for the coming fiscal year shall be adopted and approved by the incoming and outgoing Boards of Directors at their joint meeting in June."

Note: the term 'Affiliate members' means Branch members. The term was imposed on all AAUW bylaws by the recent mandate from AAUW.

Rationale

- 1. The September 30 date currently mandated for budget approval is too far removed from the beginning of the fiscal year that starts on July 1. Changing to a June date with Board approval puts the McLean Area Branch process in line with that of many other AAUW branches. A joint meeting of the incoming and outgoing Board members insures a large and representative group will reflect and protect the branch members' interests.
- 2. The proposed amendment provides that the operating budget will be available to all affiliate members for review and comment prior to approval at the joint Board meeting.
- 3. The Bylaws Committee notes that the current Bylaws provision in Article VI, Section 5, Increases in Spending, requires that any spending increase that exceeds the budget by more than \$150 shall be approved by the branch. This remains in the Bylaws.
