Advocating for Women – Action

April was <u>Sexual Assault Awareness Month</u>, an important time to focus on making workplaces safer for all workers. <u>Deborah Vagins</u>, AAUW Senior Vice President of Public Policy and Research, spoke at the **House Democrats' 2019 Issues Conference** on the work Congress needs to take on to ensure the economic security and

safety of women. Two vital bills on this effort recently saw advances. The **Be HEARD Act**, recently introduced, would provide new protections against all forms of workplace harassment, including sexual harassment. The **Equality Act**, which has now received hearings in the House Judiciary and Education and Labor Committees, would ensure that workers cannot be harassed or discriminated against based on their gender identity and sexual orientation. Both bills aim to strengthen existing civil rights laws and expand these laws' coverage and enforcement, with the goal of ensuring all people can work in a workplace free from discrimination, including harassment of any kind. On April 11, members of the AAUW Lobby Corps visited Senators' offices asking for cosponsors for the Be HEARD Act as well as the EMPOWER Act.

The **EMPOWER Act** stands for **Ending** the **Monopoly** of **Power Over Workplace** harassment through Education and Reporting Act. The bill prohibits a tax deduction for the persons having to pay an award for causing workplace harassment. For those who receive funds in connection with a settlement for workplace harassment, they can exclude that amount from their gross income, for tax purposes.

Paycheck Fairness Act Passes in House of Representatives

In the last week of March, the House of Representatives voted <u>242-187</u> to pass the <u>Paycheck</u> <u>Fairness Act</u> (H.R. 7) with bipartisan support. Since the start of the 116th Congress, AAUW has been working to ensure swift passage of this critical pay equity legislation without any weakening amendments. **Our advocacy was recognized on the House floor by Speaker Nancy Pelosi** (D-Calif.).

AAUW staff worked with Congressional offices, <u>sent several letters</u> to the Hill, and <u>organized coalition letters</u> with hundreds of signers. AAUW CEO **Kim Churches** published an <u>op-ed</u> on the importance of the bill. AAUW also submitted a <u>statement</u> for the bill's hearing record in the House Education and Labor Committee. Additionally, AAUW advocates sent more than 3,000 emails and made more than 400 calls to House offices in support of the Paycheck Fairness Act.

By passing this important bill, members of the House of Representatives who supported the bill have demonstrated their commitment to the economic security of American women and their families. The bill now moves to the Senate. AAUW urges senators to <u>pass now the Paycheck Fairness Act</u>. On March 28, three Branch members joined with the Lobby Corps, visiting 80 Senators and urging them to cosponsor as well as pass the Paycheck Fairness Act.
