November Branch Meeting

Tuesday, November 17, 2020 6:30 pm, Via ZOOM

Speakers **Drs. Earl Smith** and **Angela Hattery**, authors of the book *Policing Black Bodies* will present a powerful narrative about the regulation of African Americans and how they are treated differently from whites in many settings, including the public education and criminal justice systems. Their book makes a compelling case of how prisons, the school to prison pipeline, the policing of women and the police killing of Blacks are part of a continuum structured by systemic racism.

Earl Smith, PhD, Emeritus Distinguished Professor of American Ethnic Studies and Sociology at Wake Forest University, is currently teaching classes in Sociology, African and African American Studies, and Women & Gender Studies at the University of Delaware. Dr. Smith earned his PhD at the University of Connecticut. His teaching and research focus on the sociology of sport, social stratification, and the intersection of race and the criminal justice system. He is the author of 12 books, including his most recent books, Gender, Power and Violence (2019), and Policing Black Bodies (2018). Currently Dr. Smith is finishing the book Way Down in the Hole: Race, Intimacy and the Reproduction of Racial Ideologies in

Solitary Confinement (2021).

Angela J. Hattery is Professor of the Women & Gender Studies and co-Director of the Center for the Study and Prevention of Gender Based Violence at the University of Delaware. She is the author of 11 books, including her most recent book, *Gender, Power and Violence:*Responding to Intimate Partner Violence in Society Today (2019). This followed on the heels of Policing Black Bodies: How Black Lives are Surveilled and How to Work for Change (2018) as well as dozens of book chapters and peer reviewed articles. Dr. Hattery serves as a consultant that seek to combat violence against women and she regularly

AAUW Funds

The McLean Branch Allocations Committee met on October 15 to recommend how the funds raised in the 2020 fundraiser will be disbursed. This year's fundraiser replaced the cancelled annual Book Sale and included the chance to own one of three baseballs signed by Washington Nationals star pitcher, Max Scherzer, facilitated by Max's wife, McLean Branch member Erica Scherzer. Fundraiser proceeds will be divided in half, with 50 percent to AAUW Funds with specific fellowship designations, and the other 50 percent allocated to scholarships for women students at George Mason, Marymount, and Trinity universities.

The McLean Branch also gives STEM awards to Langley and McLean high school girls, as well as a STEM Excellence Award to a female student who presents the best science project at the Fairfax County Regional Science Fair. After Board review and approval, Branch members will be notified by email of the approved recommendation for funds allocation to be voted on at the November Branch meeting.

Last Chance Voting

Since our newsletter is released promptly on the first of the month, there is now only **November 3** left to vote in person at your precinct from **6:00 am** to **7:00 pm**. AAUW national staff has been compiling information, voter guides of candidates, as well as voting records of incumbents. To access this trove of information, for now and for the future, **go on-line to** <u>AAUWAction.org</u>. The site includes the 2020 head-to-head voter guide, and for the President of the United States, the researched facts on policy support for familiar issues such as Title IX, paid family leave, support for Pell grants and others.

The Virginia ballot lists candidates for:

- President and Vice-President from both parties and Electors for the Libertarian Party;
- Virginia Senator: incumbent Mark Warner (D) and Daniel Gade (R);
- District 8: incumbent Don Beyer (D) and Jeff Jordan (R);
- District 10: incumbent Jennifer Wexton (D) and Aliscia Andrews (R);
- District 11: Gerry Connolly (D), the incumbent, is opposed by Manga Anantatmuula (R);

The two questions on the ballot involve an amendment to the Virginia constitution to address gerrymandering which the Virginia AAUW supports and an amendment that considers taxation and exempt property for totally disabled veterans.

Make Sure Your Absentee Ballot is Counted

A Mail-in Ballot Election Kit contains two envelopes (Return and Inner "B" Ballot envelope) plus a ballot. Place the ballot in envelope B and envelope B inside the Return envelope.



Envelope bar codes are unique for each voter.

Each ballot must be in both its unique B and Return envelopes.

Ballots are rejected if

- Damaged by tears, food marks, pet marks;
- Received late:
- Envelope B information, signature, and/or date are missing; witness signature is not required;
- Without being enclosed in envelope B;
- Combined in a Return envelope with any other voter's ballot;
- Returned in the wrong voter's envelope;
- Marked with "X" or check instead of fully filled in oval (blue or black ink).

Return Ballot to Drop Box Inside Building: (Various Locations secured by election officials)

- Office of Elections: (November 3 until 7 pm).
- Any Precinct: 6 am to 7 pm (November 3 only).

Or Return Ballot to Registrar's Office of Elections:

- By mail, fax or scanned attachment to an email.
- If mailing, your ballot must be postmarked on or before election day and received by the Registrar by noon the third day after the election.

From AAUW

In the recent Washington Update, AAUW provides information about issues as well as an easy way to contact Senators and Representatives.

Issue: The Census. The year 2020 has been a tumultuous year for the Census. The Supreme Court just ruled that data collection stop on October 15. The original COVID end date was October 30. Several cases are moving through the courts questioning the count of underrepresented populations (see Hansi Lo Wang). Census counts determine the number of seats allocated to each state in the US House of Representatives. Census documents guide federal funding for several safety-net programs such as Medicaid, SNAP TANF, Section 8 housing vouchers, Head Start and other programs.

Issue: US Supreme Court nomination. On Monday, the U.S. Senate confirmed **Judge Amy Coney Barrett** to a lifetime appointment on the Supreme Court. AAUW <u>opposed</u> her nomination because her available record indicated that she would do grave harm by undermining positions central to our mission. It is our profound hope that, in her tenure on the highest court in the land, **Justice Barrett** will be inspired by the legacy of Justice Ginsburg to uphold the hard-earned rights of women and girls. AAUW has long fought for gender equity, and we are committed to working with all branches of government to ensure that our rights are not only preserved but expanded in the years ahead.

Issue: Current stimulus relief negotiations. Senators are urged to do their jobs, get Americans the relief they desperately need to be healthy, safe and economically secure, and <u>pass the HEROES Act.</u>

Finally: To learn more about AAUW's positions on the critical issues of the day and advocacy efforts regarding economic security, civil rights, and education, check out <u>letters</u>, <u>comments</u>, <u>testimony and legal briefs</u>. Recently, AAUW weighed in on a voting rights case in Alabama, offered critical input on a Title IX case out of Tennessee, and condemned a presidential Executive Order undermining race and gender equity training.

Commonwealth of Virginia

The General Assembly is still meeting, seven weeks after convening in August for what was intended as a brief gathering to finalize the state budget. It is dealing with issues of overhauling police oversight and the budget. The House and Senate have yet to resolve their differences on most of the major criminal justice legislation, such as barring police use of chokeholds, establishing citizen oversight panels, and limiting police use of military gear. **Governor Northam** has signed 27 bills including a civil penalty for violating an executive order, intended to make it easier to enforce the governor's pandemic-related restrictions. House and Senate have approved a bill that defines a requirement for all law-enforcement officers involved in a crisis intervention team program to complete a comprehensive advanced training course. A bill establishing a mental health awareness response and community understanding services alert system has passed both House and Senate.
