More to the Movement: Women of Color in the Struggle for the Vote

Elizabeth A. Novara is the American Women's History Specialist for the Library of Congress



Manuscript Division. In celebration of the 19th Amendment's 100th anniversary, **Ms. Novara** co-curated *Shall Not Be Denied: Women Fight for the Vote,* an exhibition that is now on display in the Library's Thomas Jefferson Building, and developed the presentation *More to the Movement: Women of Color in the Struggle for the Vote.* In her role as the Library's American Women's History Specialist, she provides reference service, creates collection displays, enhances online research resources, and acquires materials related to women's history for the Manuscript Division. Some of the woman suffrage materials she works with include the records of the National Woman's Party, the Papers of Susan B. Anthony, and the Papers of Elizabeth Cady Stanton. Before joining the Manuscript Division in January 2019, **Ms. Novara** was the Curator of Historical Manuscripts at the University of Maryland, College Park. She holds an MLS in Archives Management, an MA in History, and a graduate certificate in Women's Studies. She is currently pursuing a PhD in American history at the University

of Maryland, College Park. Her dissertation will be on women's political activism in Maryland from the 1890s to the 1920s, with a focus on black women's political engagement.

STEM Essay Contest

Call for Volunteer Judges and Steering Committee Members for Third Annual STEM Essay Contest



In Spring 2021, the McLean Area Branch will sponsor its third annual STEM Essay Contest open to 7th and 8th grade students (girls and boys) at local public and private schools. The contest will challenge a student to discover and publicize a woman who made a difference in Science, Technology, Engineering, or Mathematics, but who did not receive recognition for her work. Each student is asked to explain why the woman was selected and what the impact of her STEM contribution was.

We plan to give out a first-place award (\$100), a second-place award (\$50), and two Honorable Mentions (\$25 each). We will contact schools in January and make the application available via email to the schools and on our website. The deadline to submit essays is **February 12, 2021**.

This is a call for Branch members to serve as volunteer judges for the contest. If you are interested, please contact Judy Page (judypage at gmail.com or 703-847-1950). Judging will take place between February 14 and March 1. The judges will be asked to rate the essays on a set of criteria and rank their top choices.

In addition, a few members are solicited to serve on the steering committee. This group will meet twice via Zoom -- in December to review the contest guidelines and application form and in March to finalize the choice of winners based on the judges' inputs.

The winners will be invited to the Branch meeting on **March 16**, with the first-place winner reading his or her essay. March is Women's History month, and we are using this event to help celebrate it.

AAUW Funds

The McLean Branch AAUW Allocation of Funds Committee met via ZOOM to discuss and recommend allocation of money raised from the Special Fundraiser this Fall. Total funds collected during the 2020 Fundraiser totaled \$24,867. In accordance with our AAUW Policies, 50 per cent, \$12,433.50, is to be allocated to AAUW Funds, as a responsibility of participation in the National AAUW organization. The other 50 per cent, \$12,433.50, will go to Branch local scholarships, awards, and conferences.

In addition to the Fundraiser, \$1,000 was donated specifically for George Mason University. To ensure that the scholarships to all three local universities, Marymount, Trinity, and George Mason remained at the \$5,000 level the Board voted to supplement with funds from the branch reserve account for a total of \$1,351.50. The High School Awards for STEM excellence to McLean and Langley High School girls in their junior year will receive \$300 for each school. The Stem Excellence Award will be \$100.

The McLean AAUW Board Members voted to support the recommendations of the Allocations Committee. Branch Members will vote to support the Allocation of Funds for 2020 at the December Branch meeting.

On your ballot you choose the electors for the president and vice president. Then what?

On **Monday, December 14, 2020**, at **noon**, the 13 electors for the winning party in Virginia will assemble at the state capital to vote for the nominee of that party for president and vice president. All the Virginia electors must vote for the presidential and vice-presidential candidates who received the most votes during the General Election, voting for each office separately. Recounts and disputes within the states must be solved by **December 8**.

Each state sends its results in a sealed envelope to the president of the Senate, who is the vice president of the U.S., and other federal officials. The sealed envelopes are opened on **January 6** and the votes counted in a joint session of the next Congress.

How are the electors chosen?

Virginia's electors are chosen at the national conventions of the parties. The parties must give their elector names to the State Board of Elections 74 days before the General Election. Only the winning slate will vote.

All electors nationwide are members of the Electoral College. Its members come together in their own states on the first Monday after the second Wednesday in December every four years to vote for the president and vice president. The term "College" was added early in the 19th century. Each state's number of electors is based on its number of representatives plus two for each senator. Total state electoral votes add up to 535 (435 representatives plus 100 senators). The District of Columbia has three for a total of 538 Electoral votes. The winning candidate must get half of 538 plus 1 = 270 votes.

Most states require their electors to cast all their votes for the candidate who got the most votes in the General Election. In 2020, the Supreme Court ruled that states may require that. Maine and Nebraska give two votes to the winner of the statewide vote but give the rest to the winner in each congressional district.

What If there is a "Contingent Election?"

- The new House of Representatives chooses the next president if no candidate gets 270 votes. Each state gets one vote. The candidate must get 26 votes to win.
- The representatives from each state decide how that state will vote. They are not bound by the winner of the popular vote in their states.
- The new Senate chooses the next vice president if no candidate gets 270 votes. The winner must get 51 votes.
- If no presidential candidate received 270 votes, the person selected by the Senate as Vice President will serve as President until the House chooses a President.
- If no one receives 270 votes and neither the House nor the Senate elect a President and Vice President, the Speaker of the House, who is next in the line of succession, becomes Acting President on **January 20** until the House elects a President. That has never happened.

Why do we have electors instead of choosing the president directly?

Electors were created by the Founding Fathers as part of Article II, Section 1, Clause 2 of the Constitution (amendments added later). The founders did not want direct election of the president and vice president because they felt the voters would not know enough about all the candidates to make wise decisions. Initially, legislatures chose the electors, but since early in the 19th century the parties chose them.

The founders thought that only educated white men of property should vote. White men who did not own property gradually got the right to vote. The 15th Amendment gave Black men the right to vote in 1870; the 19th Amendment gave women that right in 1920. The Voting Rights Act in 1965 prohibited some state efforts to hinder Black citizens voting. However, concerns still exist about equal access to voting. The founders compromised when devising a system to elect the president. They thought if Congress chose the president, the individual would agree to Congress's wishes. If the people voted directly, there was a risk that they might elect someone who wanted too much power. To balance large states with small states, each one got two electors in addition to the number of representatives.
