We will ask each of our standing committees to consider and ponder the following questions without pre-judging the answers. For the bureaucrats reading this, these are not in order of priority, are not all inclusive nor mutually exclusive.

- Do we have the right mix of activities to attract a membership that is committed, willing and able to advance equity for girls and women into the next decade; that is, what do we offer a new generation of women who do not "do" brick and mortar programs or activities?
- What programs do we develop or sponsor that may become as eagerly awaited in our community as our book sale has been? What if, for example, we focused intensely on financial literacy both for retirees and new young workers in our community?
- What "products," if any, do we offer to brand AAUW McLean Branch? National clearly homed in on Start Smart and Work Smart to brand AAUW for a younger demographic.
- What should be our philanthropic approach? Are there activities that increase the number of women and girls we can impact? Do we change our criteria for university scholarships to support greater diversity and need in recipients?
- What policies should we focus on and at what governmental level? What would it take, as an example, to increase the number of women in our community that get paid family leave?
- What are the activities that sustain our own relationships and energy to do the hard work of change? For example, the Branch added a nighttime book club so our members who work could still build friendships.

Depending on your responses, we may decide to change not a thing; we may find just a tweak or two materially increases the impact we are having; we may find we cannot sustain a current activity; or we need to make a major investment in something brand new.

You have an incredibly committed board working hard to ensure that our Branch stays relevant and vibrant into the next decade. The work of leveling the playing field for girls and women is certainly not for the faint-hearted. We hope you will participate when called upon.



#### Virginia

Many low wage workers in Virginia live paycheck to paycheck. When there is a personal crisis, they must choose between taking time off or getting paid. **Senator Barbara Favola** has introduced a bill to help support these workers, which is cosponsored by **Senator Jennifer Boysco**.

**Senator Favola's** bill, SB 15, seeks to establish paid family leave as a class of private insurance provided to an employee to cover income loss due to several circumstances, including the birth or adoption of a child and care of a family member who has a serious health condition. This bill is necessary because current Virginia policy does not permit the sale of family leave insurance by a private insurer. SB 15 passed the Senate February 8, 2022, with a vote of 37-2-1.

**Delegate Kathy Byron** introduced a companion bill in the House, HB1156, that passed February 10, 2022, with a vote of 99-0. The bill has now been sent to the Senate Finance & Labor Committee for reconciliation.

#### Act

Members should contact elected officials on these two committees to tell them you are in favor of these compatible bills. **You may cut and paste the following for your emails:** 

\*As your constituent, I am (sending this *letter/email/calling you*) on behalf of myself and the more than 1,000 members of the American Association of University Women in 24 branches in the Commonwealth of Virginia, to urge your support for (SB 15) (HB 1156) that will establish paid family leave as a class of insurance.

AAUW of Virginia is committed to achieving equity for women and girls and creating a secure economic future for all Virginians. At some point, most workers will need time away from work to deal with a serious personal or family illness or to care for a new child. The situation becomes more acute for those individuals in the "sandwich" generation, who frequently care for both aging parents and children. The COVID pandemic has only worsened the situation, especially for working women who are already disadvantaged by the gender pay gap and cannot afford to lose pay while caring for a new baby, an aging parent or family members with COVID when they are forced to return to work prematurely. AAUW-VA strongly supports measures to make Paid Family Leave insurance available to employers and employees in Virginia. It is the right and necessary thing to do for Virginia's workers and their families. And it will go a long way to help businesses recruit and retain the workers they need.

In Congress, legislative work and action continues. A review of some issues important to AAUW follows:

AAUW's Biennial Priorities include the guarantee of equality, individual rights, and social justice for a diverse and inclusive society. We, as members,

therefore, advocate vigorous enforcement of and full access to civil and constitutional rights, including affirmative action and expanding voting rights.

**Bad News:** The Supreme Court has restored the Alabama voting map that the lower court ruled disadvantaged Black voters. The vote was 5 to 4.

**Reminder:** The Civil Rights Act of 1964 prohibits discrimination on the basis of race, color, religion, sex, or national origin... The Act prohibited discrimination in public accommodations and federally funded programs. It also strengthened the enforcement of voting rights and the desegregation of schools.

**Bad News:** The Voting Rights bill of 2021 and the John L. Lewis Voting Rights Bill failed to pass the Senate recently. They had proposed to update and improve the 1964 Act.

**Reminder:** AAUW's Biennial priorities also include greater availability of and access to a high standard of benefits and policies that promote work-life balance, including equality and affordable dependent care and paid family, medical and sick leave.

**Good news:** The \$19 trillion Covid relief deal included monetary relief for people of low income and for small businesses during the shutdown. The \$1 trillion bipartisan infrastructure bill provides transportation safety nationwide, new job opportunity for many, and money for manufacturers. The unemployment rate has dropped to 4.2 percent.

**Bad news:** Work remains for advocates and organizations to improve paid family, medical and sick leave as well as childcare in the current Congressional session.
