#### **Student Inclusion Recognition Award Winners**

The McLean Area Branch formed a DE&I Committee this year to increase diversity, inclusion, and equity in all facets of its work in the community. The Student Inclusion Recognition Award was created to acknowledge high school juniors' efforts to make their school environments welcoming to students of all backgrounds, races, and abilities.

The 2022 Student Inclusion Recognition Awards recipients are **Olivia Zhang** of McLean High School and **Talia-Rose Diorio** of Langley High School. **Ms. Zhang** and **Ms. Diorio** each received a certificate of award and \$100. They were honored at the AAUW's May Luncheon at Riverbend Country Club. Branch members were delighted to welcome the awardees mothers to the luncheon, as well.

At the luncheon, **Ms. Diorio** shared her commitment to build equitable and inclusive systems by creating within Langley High School three initiatives 1) the African American Alliance, 2) the Military Buddies Program, and 3) the Equity Coalition. **Ms. Zhang**, McLean High School's Student Government Association President, described the Be a Good Neighbor Initiative, the Student of the Month Award, and her role as CEO of Cancer Kids First, an award winning, international nonprofit organization that supports pediatric cancer patients.

All applicants for the award were asked to describe steps they had taken to promote inclusion in their school, major extracurricular activities, and to submit an essay on how they were making a difference in their school. The application reviewers were Diversity, Equity and Inclusion

#### **STEM Excellence Award Winner**

**Gaby Bautista**, a junior at George Marshall High School, has been selected as the 2022 recipient of our Branch's STEM (Science, Technology, Engineering, and Math) Excellence Award. The STEM Excellence Award is given to a female student or team from a high school in the McLean area with an outstanding project in the field of Engineering entered in the Fairfax County Regional Science and Engineering Fair.

This year, the students participated in a hybrid science fair with both virtual and limited in-person judging. Each student submitted a six-minute video for the judges to review. Myrtle Hendricks-Corrales and Judy Page served as judges for our Branch. They were impressed by the work done by Gaby on the project, "Angular Deflection of a Cantilever Beam," including her video presentation. In addition to our award, Gaby was selected as a first-place category winner in Engineering Technology: Statics and Dynamics. As a student with one of the highest-ranking projects at the regional level, she was invited to and participated at the Virginia State Science

## STEM Achievement Awards Recipients from McLean High School Announced

Three female students have been selected as the recipients of the branch's high school STEM Achievement Awards at McLean High School for 2022. For the last nine years, the McLean Area Branch has partnered with counselors at local high schools to present these achievement awards to female students finishing their junior year. The branch instituted the awards to encourage young women to pursue educational opportunities related to STEM (Science, Technology, Engineering, and Math).

The criteria for the awards include a demonstrated record of overall academic success and a distinguished record of achievement in either math, science, or computer science. The award for computer science was added in 2021 to recognize students' achievements in this important field. A career center counselor at the school manages the process of selecting the students. #### **Virginia Primaries**

Many Virginians do not realize that their congressional district may have changed. Most of our members will now be either in Virginia's 8th (if they live inside the beltway) or the 11th (if they live outside the beltway). There are some exceptions, so it is important to check so you are knowledgeable about the candidates and the issues. If you are unsure of your district, click

Your state delegates and senators may have also changed, but we will not be voting for them till November 2023. (This may be subject to change depending on the outcome of a lawsuit.)

Congressional District 8 has a Democratic primary. **Victoria Virasingh** is challenging Representative Don Byer. You can vote at your local polling place on **June 21** or apply for an absentee ballot. The link for the absentee ballot is <u>https://www.fairfaxcounty.gov/elections/early-voting</u>. The ballot will be sent to you in the mail. For more information, ballotpedia.org is a source. The Republican candidate is being chosen at a party convention.

### **Ghost Guns: How to Curtail Their Increased Use in Crimes**

The growth in the availability and use of "ghost guns" is the hot topic in gun control today.

A ghost gun is a firearm made by a private individual from a variety of gun parts purchased as a kit or separately. The ghost gun does not have a commercially applied serial number, and this makes it very difficult to trace the gun in criminal investigations. It also is not subject to federal or state commercial background check regulations.

Legislation has been introduced in the last two sessions of Congress to ban ghost guns, but the legislation has not progressed out of committee. Some states have passed legislation that address ghost guns, but they continue to proliferate in crimes.

**President Biden** has made enforcement of gun regulations a priority and has launched several gun control initiatives. In April, the Department of Justice's Bureau of Alcohol, Tobacco, Firearms, and Explosives published a final rule that makes ghost guns without serial numbers illegal. The rule becomes effective in August of this year.

The final rule bans the business of manufacturing the most accessible ghost guns, such as "buy build shoot" kits without serial numbers that individuals can buy online or at a store without a background check and can readily assemble into a working firearm in as little as 30 minutes. The rule clarifies that these kits qualify as "firearms" under the Gun Control Act of 1968. Commercial manufacturers of such kits must become licensed and include serial numbers on the kits' frame or receiver, and commercial sellers of these kits must become federally licensed and run background checks prior to a sale – just like they must do with other commercially made firearms. In addition, if commercially licensed gun vendors acquire a "ghost gun," they must immediately add a serial number to it. Persons who violate the rule are subject to fines and jail time.

Ghost guns may only be a small percentage of the guns law enforcement find every year at crime scenes but the final rule represents another effort to curtail gun violence in America. As one professor stated, "The rule 'really throws a monkey wrench into the ghost gun market." *Brady: United Against Gun Violence* supported the rulemaking and urged people to state their support for its adoption. The rule is expected to be challenged by guns rights organizations, such as <u>*Gun Owners of America*</u>.

At this point in time, with the final rule, there does not seem to be much AAUW can do to support the prohibition on ghost guns. If the rule is challenged, there may be some action we can take.
