# **January Virginia AAUW Program**

Mary Church Terrell Activist, Suffragist for Life

Activist and suffragist **Mary Church Terrell** was shown to be a rebel into her 90s in a presentation at the January 21 Branch Meeting. **Alison M. Parker** spoke about her book, *Unceasing Militant: The Life of Mary Church Terrell*, published in 2020. **Terrell** (1863-1954), a hidden figure, is unknown to most people. She was a founding member of the NAACP and helped found several organizations for

Black women. After a fight over race, she became a member of AAUW when the national organization changed its bylaws so that the only requirement for membership was to be a woman with a college degree from an AAUW-approved university.

Among her many accomplishments, she was instrumental in the desegregation of movie theaters in 1953. She was known by the Black press as the "female Booker T. Washington."

## Presidents' Message

AAUW National's website reads "EQUITY NOW – Together we can achieve a vision of equal opportunity for all". These words reflect a vision, but they do not reflect reality.

While AAUW acknowledges the educational disparity among minority women, AAUW continues to exclude some 55% of American women from AAUW membership due to its educational requirement. The McLean Branch Board (1) agrees this is morally wrong for reasons that AAUW National itself has expressly and publicly acknowledged and (2) overwhelmingly voted to reduce our Branch contribution to AAUW National, both as a percentage of our fundraising effort and in real dollars. The Board further instructed us to urge other Virginia branches and the State organization to do the same. We have written to AAUW National, with copies to State and Northern District leadership. We will keep our membership apprised of the response.

Many women and children in our own community face very real barriers to opportunity. Due to COVID, they have fallen further behind. It is the Board's vision that we use our collective resources to make a difference close to home through community engagement.

The Board has identified four ways, consistent with our strategic vision, in which McLean AAUW can actively support increased empowerment and equity for girls and women in the classroom and the workplace:

- Partnering with a Title 1 elementary school to address some of their unmet needs;
- Providing English as a Second Language (ESL) instruction through established Fairfax County programs;
- Assisting SHARE, an interfaith cooperative program which provides food, clothing, and other services to the needy in our community; and
- Engaging with the McLean Community Center's student representatives and working in partnership with the student representatives in outreach efforts to youth in our area.

Our General Membership meeting on Tuesday, April 18, at the McLean Community Center will be a social event with beverages and heavy hors d'oeuvres. We will hold a discussion as to what members would like to gain from AAUW McLean membership. We are particularly interested in hearing from our newest members. Additionally, we will seek members' interests in community engagement. Our goal is to understand how each of us can make a difference in our community, while fostering a sense of shared mission and belonging among our members. We hope you will join us!

#### **AAUW Funds**

Allocation of Funds Committee Report was presented to the McLean Area Branch Board of Directors on December 14, 2022. The Total Amount of the Fundraising activities as of 12/01/2022, was **\$15,196.77**. This was the amount considered at the Allocation of Funds Committee Meeting.

The Report of the 2022 Fundraising activities as of December 13, 2022, stated that the Total Amount raised, so far, is **\$17,047.11**.

After a deliberative discussion of AAUW Funds Allocations and the AAUW requirement for a college/university degree, the Board voted to allocate to AAUW Funds the same amount allocated to each college/university. It was recommended that a letter be sent to the National Headquarters of AAUW on why the AAUW McLean Area Branch is limiting its donation to AAUW Funds because of the degree requirement for membership.

As a public-school educator in Fairfax County and Alexandria, she was an elementary school teacher, a school administrator, and a director of professional development where she learned the importance of leadership to effect change. In retirement, she uses her acquired skills to work with community groups helping those in need and in the Presbyterian Church at the local and regional level helping churches find pastors. She is fascinated by local, state, and National politics and advocates for candidates and initiatives that support those do not to have a voice in the political process.



The Public Policy Committee would like to thank everyone who contacted their state delegates and senators in response to the proposed amended social studies standards for students in the Commonwealth that were published last year. A third version has now been published by the Virginia Superintendent of Public Instruction and this version addresses many of the issues that were lacking in its predecessor.

This is a busy time for the Virginia Assembly. The short session (45 days) started on January 11 and will continue until February 25, 2023. A very important day in the session is **Crossover Day on February 8**. This is the day when each of the chambers of the General Assembly sends the bills it has passed to the other chamber for its consideration.

The following legislative and policy priorities for AAUW of Virginia are those we will focus on for the 2023 Virginia General Assembly legislative session and beyond:

- Protect access to abortion and women's right to make personal reproductive decisions with the medical care providers.
- Eliminate systemic racism and sexism through changes to Virginia law and regulations.
- Make childcare affordable and readily available for all families.
- · Protect full access to voting.
- Ensure full public-school funding and protect teachers from harassment and liability claims.

Some Branch members travelled to Richmond for "Lobby Day" to meet with elected representatives and their staffs with the goal of gaining support for AAUW's 2023 legislative priorities.

The Diversity, Equity, and Inclusion Committee (DE&I) is offering an opportunity for Branch members to volunteer and promote an inclusive community by assisting with the upcoming Student Inclusion Recognition Awards.

As part of its goal to increase diversity, equity, inclusion, and sense of belonging in all aspects of work in the community, the McLean Area Branch created the Student Inclusion Recognition Award to acknowledge high school juniors' efforts to make their school environments welcoming to students of all backgrounds, race/ethnicities, and abilities. Last year, a student from Langley and McLean High Schools were both presented with an AAUW Certificate of Appreciation at their school's awards ceremony, and each given a \$100 check. At a Branch meeting, we had the opportunity to honor the awardees and learn of their outstanding work. Information on the awardees is posted on the McLean Branch website.

The Branch plans to double the number of schools participating this year by extending the award to two Title One schools in the area. Title One is a federal education program that supports low-income students who attend high poverty schools, as determined by the number of students who qualify for free or reduced meals.

The process for receiving, circulating, and reviewing applications is straight-forward and takes place within a limited timeframe this spring. It is inspirational to read the applications and learn about the substantive activities that students have undertaken to promote inclusion.
